SUBJECT: REQUEST FOR APPROVAL OF RESOLUTION 01-05 OF THE

SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, DESIGNATING MARCH AS WOMEN'S HISTORY MONTH TO BE CEL-

EBRATED IN MIAMI-DADE COUNTY PUBLIC SCHOOLS

Florida Statute 233.061 requires instruction in women's contributions to the United States. Throughout each school year, Miami-Dade County Public Schools' students study the many contributions of women which also is a requirement of the district's pupil progression plan and its K-12 social studies instructional program. Additionally, each year the United States Congress issues a resolution designating March as Women's History Month, and a presidential proclamation encourages all Americans to observe the month as well.

The Division of Social Sciences/Special Programs, in cooperation with the Community Coalition for Women's History, will provide instructional materials/resources to all schools to support school-based activities for Women's History Month. These materials will include the unique collage of achievers who are members of our present School Board: Chair Perla Tabares Hantman, Ms. Betsy Kaplan, Mrs. Manty Sabates Morse, Ms. Jacqueline Pepper and Dr. Marta Pérez as well as the student adviser to the Board, Ms. Marylynne Hunt-Dorta. Additionally, the Division of Social Sciences/Special Programs has developed and initiated implementation of a women's history curriculum resource guide to support this mandate. Training has been provided to a representative from each school, and the resource guide has been distributed to all schools.

Therefore, it is fitting that the Board approve Resolution 01-05 of the School Board of Miami-Dade County, Florida, in a continuing effort to heighten awareness and appreciation of the many significant contributions of the courageous women who have helped make our nation strong and our world a better place in which to live.

WHEREAS, in Miami-Dade County Public Schools, the study of the contributions of women to the United States is mandatory;
