On August 17, 2001, the School Board directed the Superintendent to collaborate with the Foundation for Democracy in Africa in establishing sister-school partnerships and student exchange programs with schools in Africa. Since then, representatives of the district, foundation and community have developed a pilot program to be introduced this fall at Carol City Elementary, Carol City Middle, and Miami Carol City Senior High schools.

With the 5th Annual Africando U.S.-Africa Trade & Investment Symposium and Arts & Culture Festival to be held in Miami May 8-12, it is important that Miami-Dade citizens be aware of the district's partnership with the Foundation for Democracy in Africa and its potential for promoting trade and cultural exchange between the people of our nation and Africa. It is recommended, therefore, that the School Board approve a resolution recognizing that partnership and its benefits.

This item does not appear on the published agenda. Good cause to vary from the agenda exists because the Africando symposium will take place prior to the next School Board meeting.

WHEREAS, the pilot program is consistent with the aims of the 5th Annual Africando U.S.-Africa Trade & Investment Symposium and Arts & Culture Festival, to be held in Miami May 8-12, 2002; and

WHEREAS, it is important that Miami-Dade County's citizens be aware of the School Board's partnership with the Foundation for Democracy in Africa and its great potential for promoting trade and cultural exchange between the people of our nation and Africa;
