Through Kristi House, an Oriowitz-Lee children's advocacy center, services are provided to child victims of sexual abuse and their families. Its staff works collaboratively with law enforcement; child protective services; and medical, legal, and mental health agencies to accomplish its mission, which is to provide opportunities for individuals to explore social, educational and rehabilitative activities designed to balance and stabilize their emotional and psycho-social health as a result of their traumatic experience.

Children who are healthy both mentally and physically are more likely to succeed in school. Therefore, it is fitting that this School Board recognize Kristi House and its support staff and programs for the positive impact they have had and continue to have on many of Miami-Dade County Public Schools' children.
