**LINK TO DISTRICT
STRATEGIC PLAN:**

In 1957, Myrtle Grove Elementary School opened its doors to 300 students in Northwest Miami-Dade County. Fifty years later, teachers, students, administrators and staff are celebrating the school's Golden Anniversary using the theme "Shining Brighter, 50 Years Later." The anniversary celebration has provided faculty and alumni an opportunity to reflect on the many achievements of the school whose graduates include physicians, educators, athletes, actors and business and community leaders.

When Myrtle Grove Elementary School opened, the school was comprised of several portables. Today, the current school is housed in a 54,953 square-foot building with a physical education facility and an extended parking lot under construction. Recognizing that school discipline and student safety provide an educational environment that enhances academic enrichment, Myrtle Grove Elementary School has included in its curriculum a program called "Conscious Discipline." The program involves a three-step process that helps students and teachers deal with anger in non-aggressive ways. The students learn to stop, take a deep breath and calm down.

As part of the anniversary celebrations, the school will bury a time capsule which will contain items selected by each grade level. It is appropriate, therefore, that the School Board endorse the recognition of the 50th anniversary of Myrtle Grove Elementary School.
