Stop Hunger, Inc. is a non-profit food bank and food pantry founded by former elected official Julius Littman and is the largest independent food distributor in Florida. Stop Hunger Inc.'s mission is to provide free food and supplemental meals to the poor, needy and homeless in South Florida. It feeds over 27,000 low income families and individuals in Dade, Broward and Palm Beach counties monthly and accounts for over 500,000 meals a month.

Stop Hunger, Inc. has 70 registered Food Bank distribution agencies that distribute to central communities, feeding 25,000 people. Over 2,200 families at their North Miami facility receive a free shopping cart of food monthly through its "Jules Food Pantry" program. Stop Hunger, Inc. serves the working poor, single parents, immigrants, the elderly, the homeless, the unemployed, HIV/AIDS patients, the mentally and physically disabled, and students. Its food and distribution program is 100% free of cost to these individuals.

Stop Hunger, Inc. also provides food and commodities to disaster relief organizations including FEMA, American Red Cross, the United States Army and the Salvation Army in times of natural disasters.
